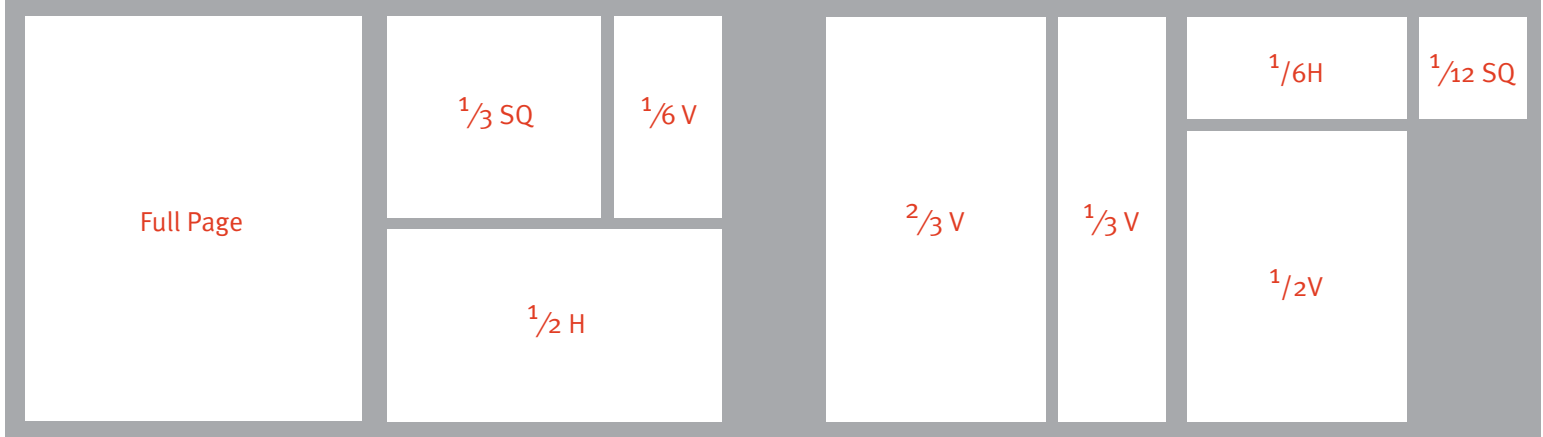

DPI SPECIFICATIONS *Seattle* magazine is printed with a 133 line screen. Provide all photos at 300 dpi. Line art should be provided at 600–1200 dpi.

***BLEED SPECIFICATIONS** Image area not intended to be trimmed must be .3125" in from the trim size of 8.375" x 10.875". Material intended to bleed must be furnished with a minimum of .25" image area beyond the trim (8.875" x 11.375"). On anything less than .25" bleed, publisher cannot guarantee consistent bleed.

TRIM SIZE 8.375" x 10.875"

LIVE AREA All type or graphics not intended to trim should be positioned .3125" from trim.

GUTTER SAFETY All copy should be placed .375" from either side of trim.

mechanical specifications

The following specifications should be used in the preparation of digital files and color proofs.

DIGITAL FILES Ads should be supplied on a CD or via FTP or email in Macintosh format and created in any Adobe product or Quark; or you can supply a high-res PDF (CMYK, 300 DPI, fonts embedded). All images should be converted to CMYK and at 300 dpi. All fonts should be converted to outlines or supplied as Suitcases along with the font manufacturer font name and version. Use stylized fonts, and do not apply style attributes to basic fonts. Black-and-white ads must be accompanied by a laser proof. Color ads must be accompanied by a color proof (i.e., color copy print, thermal print, matchprint). Please contact the Production Manager if your digital file does not conform to these standards. The publication is not responsible for color or content of proofs or files that do not conform to the specifications listed. We do not accept film.
